

Sub: Special Camps to be organized at every polling station on 2nd March (Saturday) and 3rd March, 2019 (Sunday) for enrollment of left out eligible voters-regarding

Madam/Sir,

I am directed to state that the Commission, keeping in view of the impending general election to Lok Sabha, 2019 and in order to provide further opportunity in campaign mode to all un-enrolled eligible persons to get their names registered in the electoral rolls during continuous updation period after final publication of roll, so that they are not deprived of voting at elections, has directed that special camps for this purpose shall be organized on **2nd March (Saturday) and 3rd March, 2019 (Sunday)** in each polling station for enrolment of left out eligible electors. Booth Level Officers (BLOs) shall remain present in the camps along with the copies of final electoral rolls, 2019. One copy of the electoral roll shall be made available in the polling station so that electors can check their names in the rolls. The electoral rolls shall also be read out publically during the camp to facilitate illiterate voters. BLO shall keep adequate copies of Forms 6,7, 8, 8A with him/her to facilitate filling up forms by interested persons.


2. Wide publicity shall be given for special campaign days through all media channels including print and electronic media etc. The CEO and DEOs must announce these special campaigns through Press Releases. All recognized political parties must be informed in writing by DEOs about the camps. Political parties should be requested to depute their BLAs to remain present in the camps. Wide publicity should also be given to the fact that EPIC holders must also check their names in electoral rolls and fill up Form 6 if their name does not exist in the roll for

some reason. Publicity should also be given to the fact that EPIC is only the identification document and does not guarantee franchise if name of the person is not in the electoral roll of the concerned polling station.

3. All the Forms received during these campaign days shall be disposed of by 14th March, 2019 positively. The BLOs must immediately complete the physical verification and then submit report to the ERO. ERO should complete the due process of law and dispose of the forms, received during the camps within 11 days (i.e. by 14th March, 2019).

4. A format (as enclosed herewith) has been prescribed to monitor the Forms received during the camps will be made available at CEOs' portal at appropriate time. Assembly constituency-wise data entry in respect of Forms received during Camps shall be done on the website of the Commission at CEOs' Portal. The data entry, in respect of the forms, received during the campaign, is required to be done on the website latest by 4th March, 2019 and information about disposal of Forms shall be given through website by 14th March, 2019.
